Applications are invited from eligible interested candidates residing permanently in the district of Birbhum for engagement to the post of Data Entry Operator (DEO)purely temporary on contractual basis for a period of three years initially in connection with computerization of Land Records, as per the extant rules as laid down in the Finance Department Memorandum No. 5859-F(Y) dated 22.07.2013 read with the Order No.205-Estt/13099/11/19 dated 16.01.2024 of the Department of Land & Land reforms and Refugee Relief and Rehabilitation, Govt. of West Bengal.

The selected candidates may be posted at any of the Offices of BL&LRO, SDL&LRO and DL&LRO under the Land Reforms Set-Up of this District.

Renewal of these posts beyondthe period of three years will be subject to satisfactory performance and as per requirement of the project. If the performance of any Data Entry Operator so engaged, is found to be not satisfactory at any point of time during his service period, his service may be terminated by the authority concerned forthwith, without any liability.

2.	Minimum Qualification	Applicant must be a Graduate with a certificate in computer Applications and having proficiency in Microsoft Word, Excel and basic internet applications.	
3.	Age	Must be between 21 to 45 Years as on 01.11.2024.	
4.	Professional Fee/Remuneration	Consolidated profession fee/remuneration of ₹ 11,000/- (Eleven Thousand) only per month.

Mode of Selection:

The selection process will consists of three tiers tests—written test, practical test and interview.

A. WRITTEN TEST:

Applicant must appear in a Written Test for 30 Marks having following break up:

Subject	Marks
Arithmetic (Madhyamik Standard)	10
General Knowledge	10
Computer Knowledge	10

There shall be multiple choice question pattern. For every wrong answer, there shall be a deduction of 1/3<sup>rd</sup> of the total marks allotted to the question.

Candidates shall be called for a Practical Test on 1:5 i.e. for 40 number of vacancies, 200 candidates shall be called for Practical Test on the basis of marks obtained in the written test.

- B. Practical Test (Computer): This shall carry 10 Marks.
- C. Interview: This shall carry 10 Marks.

Final panel of the selected candidates shall be made on the basis of total marks secured by the candidates in Written Test, Practical Test and Interview.
